Cookies

Do not know what a cookie is? Go to http://en.wikipedia.org/wiki/HTTP cookie

The Performwork websites need to use a Session Cookie to know what information is to be displayed whenever you click on an active element (e.g. button, menu etc.). Session Cookies are deleted when you close your browser.

Our websites also use Persistent Cookies to:

- Know that you have visited the site before so it does not have to redisplay the cookie message on the opening screen.
- Pre-select certain options.

Google Analytics

We use Google Analytics to help provide us with anonymous web analytics for our website.

URL Tokens

The Performwork websites use tokens within the URL to hold sensitive data in an encrypted format and to enable you to remain logged in.

Registration

When you register we store in encrypted format:

- Your current and any previously used passwords
- The email address associated with your subscription.

We may use the email address to send important information related to your account (account activation, password reset, subscription status, notification of new features etc.).

Paid Subscriptions

When an account is upgraded to a paid subscription, we store the information provided by the payment processor, including transaction ID, date and time, amount of transaction. The name and address is stored in case it's included with payment information. We use this information to change the status of the account, to provide an invoice and to allow changes of the subscription status.

IMPORTANT

If you use the Logout option on the main menu the temporary key used to "decode" URL tokens will be deactivated, this ensures no one can then use use your browser history to access your data after you have closed your browser.

You should always LOGOUT this way when:

- Using a public computer (e.g. Internet Cafe, Library)
- Using someone else's computer, even a friend's computer.

If in doubt logout!
